### **PARTICIPANTS RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

I, the undersigned, hereby request permission to enter the premises of **Billings Livestock Commission & Horse Sales & Arena. Pistols & Crystals Showdown Barrel Race** and to participate in the “U” **Barrel Racing Championships**.

I, the undersigned, on behalf of myself, my personal representative, heirs, next of kin, spouses and assigns, do hereby:

1. **RELEASE, DISCHARGE AND COVENANT NOT TO SUE** “U” Barrel Racing Championships, Top Gun Productions, Billings Livestock Horse Sale (Billings Livestock Commission) or other owners, and each of them, their directors, officers, agents, employees, heirs and assigns (all hereinafter collectively referred to as “releasees”) from any and all claims and liability arising out of strict liability or ordinary negligence of releasees harmless and to indemnify releasees from any claim, judgment or expenses releasees may incur arising out of my activities or presence in the areas.
2. **UNDERSTAND** that my entry into the area and/or participation in the “U” Barrel Racing Championships contains **DANGER AND RISK OR DEATH TO MYSELF**, that conditions of the arena change from time to time and may become more hazardous, that horses may be dangerous and unpredictable, and that there is **INHERENT DANGER** in an event such as this which I appreciate and voluntarily assume because I choose to do so. I further understand that the arena surface, access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to me. I further understand that other participants may pose a danger to me, but nevertheless, I **VOLUNTARILY ELECT TO ACCEPT**

ALL RISKS connected with my entry into the areas and/or participation in this event.

3. **AGREE** that this agreement shall apply to any incident, injury accident or death occurring on the above date and FOR A PERIOD OF ONE (1) YEAR THEREAFTER. All subsequent agreements and release documents signed by me shall amplify, but shall in no way limit the provisions of this document.
4. **RELEASOR AGREES TO INDEMNIFY** the Releases and each of them from any loss, liability, damage or costs and attorneys fees they may incur due to my presence and/or participation in the above-described activities whether caused by the negligence of the Releasees or otherwise.

I HAVE READ THIS DOCUMENT; I UNDERSTAND IT IS A RELEASE OF ALL CLAIMS.

I APPRECIATE AND ASSUME ALL RISKS INHERENT IN BARREL RACING AND BARREL RACING RELATED ACTIVITIES.
